Quantitative easing, extraordinary measures, whatever it takes, negative interest rates, bazooka, next generation EU, double whammy and special assets Bundeswehr. Since 2009 (global financial crisis), the list of new phenomena in monetary and fiscal policy is getting longer and longer. Old ,truths' of monetary and fiscal policy (and other policy fields) do not sufficiently contribute to answering the questions raised. With the climate crisis and the Corona pandemic, as well as a direct war by the nuclear power Russia, there are also events that take the global order unprepared. The relationship between market and state is seeking a new balance. In addition, the demarcation between

national and international is increasingly being discussed. The 73rd Monetary Workshop will address these fundamental questions.
